# Eunice Chua, Financial Industry Disputes Resolution Centre (FIDReC) and Singapore Management University (SMU) (Moderator)

Ms Eunice Chua is the Chief Executive Officer (CEO) of FIDReC and a Research Fellow at the SMU School of Law. She is qualified as an Advocate and Solicitor of the Singapore Supreme Court and an Associate Mediator of the Singapore Mediation Centre (SMC). A First-Class Honours law graduate from the National University of Singapore, Eunice served as a Justices' Law Clerk in the Singapore Supreme Court and later obtained a Masters of Law from Harvard. On her return, she was appointed Assistant Registrar of the Singapore Supreme Court, Magistrate of the Singapore State Courts and Assistant Director of the SMC. She later joined the Singapore International Mediation Centre as its first Deputy CEO before her next role as Assistant Professor at the SMU School of Law, where she specialised in alternative dispute resolution, evidence and procedure. Eunice has conducted mediation training both locally and internationally and continues to coach students for international mediation and mooting competitions. Her writings appear in leading publications and academic journals in her field.
