Introduction

CIArb Singapore Centenary Conference

The Singapore Branch is commemorating the 100th anniversary of the founding of the Chartered Institute of Arbitrators by organizing the CIArb Singapore Centenary Conference on 3-4 September, 2015 in Singapore, at the Marina Bay Sands. The Singapore Centenary Conference is one of the flagship events to celebrate the Centenary, following celebrations in Birmingham, Hong Kong, London and Zambia. The theme of the Singapore Conference is "The Age of Innovation: Addressing the Perils and Promises of Arbitration". We are delighted to have the Honourable Chief Justice Sundaresh Menon, who is also the Patron of the Institute, as the Key Note Speaker, and many distinguished speakers from around the world speaking on innovations that will address new challenges and shape the future of arbitration. The new CIArb Guidelines will also be launched and discussed during this Conference.

Talk by Neil Kaplan CBE QC on 'The Do's and Don't's of Presenting a Case to Arbitrators'

CIArb-WIPO-SIAC Intellectual Property, Media & Technology Arbitration Symposium 2014: Innovation Under The Global Spotlight – Overcoming Challenges, Changing Mindsets

The Branch in association with the WIPO Arbitration and Mediation Center and the Singapore International Arbitration Centre organised the CIArb-WIPO-SIAC Intellectual Property, Media & Technology Arbitration Symposium 2014 (IPMTAS 2014), at the Marina Bay Sands Convention Centre, Singapore on 13 and 14 March 2014. The Senior Minister of State for Law & Education, Ms Indranee Rajah was the Guest of Honour and Keynote Speaker.

The 2-day Symposium was attended by over 120 delegates and distinguished speakers, leading IP, arbitration and ADR experts and business leaders from around the world who shared their experiences and addressed key and topical issues, best practices and new solutions on the avoidance and resolution of disputes in the converging areas of IP, media and technology. The symposium was particularly significant following on the heels of the Singapore IP Hub Master Plan announced by the Singapore government under which, Singapore aims to become a global IP hub with a world-class infrastructure and eco-system where businesses and investors are secure in protecting their rights, transacting deals across borders and resolving their disputes. We were delighted to have the support of the IP Academy and the Intellectual Property Office of Singapore and many other organizations for this symposium.

CIArb Singapore Branch Young Members Essay Competition

2014 was the second year running that the CIArb Singapore Branch held a Young Members Essay Competition in conjunction with Thirty Nine Essex Street Chambers. The Essay Title was "Asia's diversity: the strength of Asia's arbitration centres lies in their differences not in their similarities".

The winners were announced by Justice Quentin Loh at the 2014 Members' Evening, where Justice Loh noted the high quality of the entries and the judges' difficulties in separating the top candidates during the several stages of the judging process.
