


Chartered Institute of Arbitrators Singapore Branch: 2016 AGM – Directors' Report


Introduction


2015 was a milestone year for the Chartered Institute of Arbitrators, the Singapore Branch and indeed, for Singapore. It marked the 100th anniversary of the founding of the Chartered Institute and the 50th anniversary of Singapore as an independent nation. It also marked the 5th anniversary of the formation of the Singapore Branch. The Chartered Institute, the Singapore Branch and Singapore can look back with pride at the accomplishments and successes that each has enjoyed over the past decades.

Membership

As of August 2016, the Singapore Branch has 382 members, namely, 116 Members, 91 Associate and 175 Fellows.

Events

Some of the major events held in 2015/2016, include:

1. CIArb Singapore Centenary Conference

The CIArb Singapore Centenary Celebration Conference held on 3 & 4 September 2015 at Marina Bay Sands was a resounding success, with over 320 delegates, comprising of senior judges and judicial officers, international arbitration counsel, representatives of arbitral institutions, in-house legal counsel, arbitrators, industry professionals and law students attending the Conference. The highlight of the Conference was the keynote address entitled "Standards in need of bearers: Encouraging reform from within" by the Honourable the Chief Justice Sundaresh Menon, Chief Justice of Singapore and Patron of CIArb. The Conference also saw the global launch of the CIArb Guidelines with three panel sessions dedicated to discussing some of the more widely used guidelines.

2. <u>4th ALA(S)-CIArb-SCCA Golf Triangular Challenge</u>

Over the last three years, this friendly annual triangular golf challenge tournament has helped to forge stronger ties among the ASEAN Law Association (Singapore), the CIArb Singapore Branch and the Singapore Corporate Counsel Association and to provide a platform for members of these associations to interact with one another. The 4th ASEAN Law Association-Singapore Corporate Counsel Association Golf triangular challenge together with the CIArb Singapore Branch's annual golf tournament was held on 24 June 2016 at Tanah Merah Country Club. The debate which featured the President and members of the SIAC Court of Arbitration, Mr Gary Born, Prof Bernard Hanotiau, Mr Toby Landau QC and Ms Lucy Reed, had an overwhelming turnout of 266. Francis Xavier, Chairman of CIArb Singapore Branch moderated the debate. With the success of the debate, CIArb Singapore and SIAC are keen to jointly organize this event annually.
