This full-day' training course is a unique programme designed to help men and women see the role played by biases and explore ways to address and overcome bias in order to make a difference to Diversit ity.

Participants will participate in a day of mini-lectures, participatory exercises and guided workshops in order to: examine the value that diversity brings to international dispute resolution; see and understand bias-personally and in the International dispute resolution; see and understand bias-personally and in the workplace: explore what can be done to respond to bias and progress toward diversity and inclusiveness; and come away with practical tips and ways to promote diversity. The goal is for each person to leave the workshop with a personal diversity plan - a goal that is achievable in that person's circumstances by a series of actions leading to behavioural change. A follow up survey will assess the long-term influence of the Toolkit training for each participant.

She was one of the first Chartered Arbitrators in Asia and has taught and assessed for the institute for 20 years. As one of the two founders of ArbitralWomen, she has been studying the role of women and promoting women in international dispute resolution for 25 years. In 2006 she moderated the first panel to deal with Diversity in a seminal conference entitled moderated the inst panel to deal with Diversity in a seminal conterence entity "The Changing Face of International Arbitration" and since then has regularly presented Diversity issues on four continents. With a grant from AAA-ICDR she led the creation of the Diversity Toolkit, and since its inauguration in late 2018 has presented it in the U.S., Canada and Mexico, as well as training others to deliver it in their own jurisdictions.
