With the exponential rise in global trade, cross-border commercial relationships, and cyber-transactions, the need for clear and organised structures of dispute resolution has never been

greater. This is particularly in the field of investor-state dispute settlement ("ISDS"), which has remained a popular mode of dispute resolution, especially for aggrieved investors seeking recourse against governments for perceived regulatory wrongs or unfair treatment. The interaction of ISDS with mediation is one that is insufficiently explored, but yet is crucial given that mediation has the potential to save much time and cost compared to a long-drawn investment arbitration, which commonly takes close to a decade to fully resolve.

As such, this event will be a timely discussion between two leaders in the field of investment and commercial arbitration, and international dispute resolution generally. Gabrielle and Francis will share their thoughts and views on the current state of ISDS, trends in international dispute resolution, and how mediation can become a more popular avenue for resolving disputes between investors and states.

SPEAKER'S PROFILE

Gabrielle Kaufmann-Kohler is a partner of Lévy Kaufmann-Kohler, Geneva, and practices international commercial and investment arbitration, having acted in around 250 international arbitrations, mainly as president. She regularly ranks among the top arbitrators worldwide; a study on investment arbitration released in 2016 concluded that she was the "most influential arbitrator in the world". She appears on numerous institutional panels (including ICC, ICSID, SIAC, CIETAC).

Professor Emerita at Geneva University, where she taught private international law and international arbitration, Gabrielle is the founder of the Geneva LLM in International Dispute Settlement (MIDS) and co-founder of the Foundation for International Arbitration Advocacy (FIAA). She is or was a visiting professor at National University of Singapore, Georgetown Law, Sciences Po Paris, the MIDS, and Tsinghua University Beijing.

Honorary President of ICCA (since 2020) and of the Swiss Arbitration Association (ASA), Gabrielle is also among other leadership positions a former member of the ICC Court, LCIA Court, and AAA Board, and a member of the Swiss delegation to UNCITRAL.
